I understand, upon my certification as a Reflexology Therapist, it is mandatory to join the RCRT (Registered Canadian Reflexology Therapist) program within two (2) weeks of certification.

I have read and accept all provisions of the Payment and Refund Policy and the Extension Policy (see attached).

I understand that, to maintain my RCRT designation with RAC, my yearly membership is mandatory. Should I allow my membership to lapse, I no longer can utilize the RCRT designation for any purpose whatsoever.

I also agree that if I do not renew my membership within six (6) months of my membership expiration date, my membership will lapse. At that time, to bring my membership to current status, I will have to pay a rejoining fee of \$75 (plus GST/HST), an RCRT fee of \$25 (plus GST/HST), and the annual membership fee (plus GST/HST).

If my RCRT Professional Membership lapses three (3) years or more, I understand that I will have to take the RAC Foot Theoretical and Practical Challenge Exams of the current curriculum* at a cost of \$75 each*. If I do not pass both exams with satisfactory grades (80% or higher), I will have to complete a Foot Refresher Course (Theoretical and/or Practical) at current cost. If I am not successful at the Foot Refresher Course (Theoretical and/or Practical), I will have to retake the RAC Foot Reflexology Course at the current cost. * Manuals of current curriculum are available for purchase from RAC.
